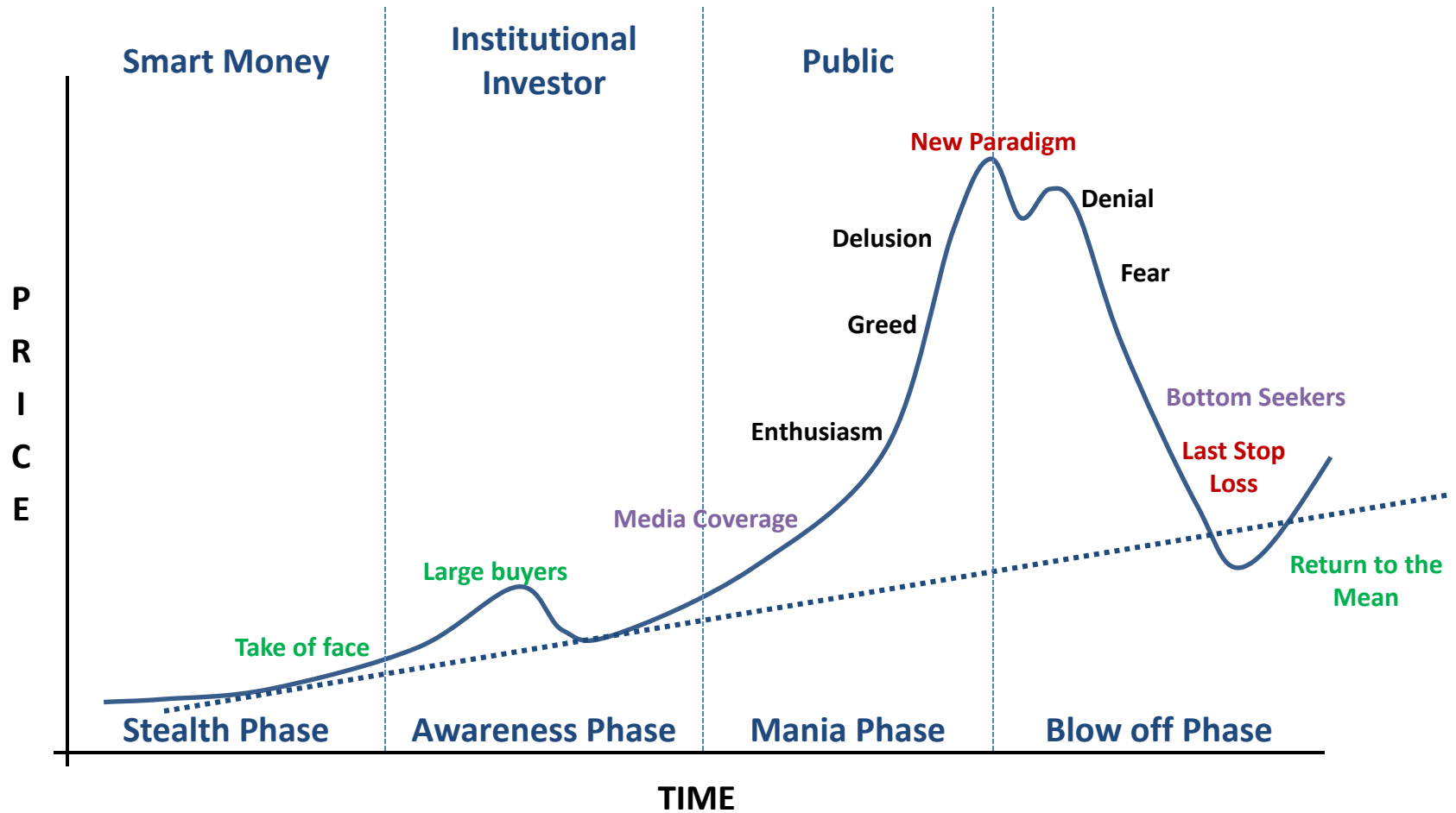

# Emotional Investor Cycles

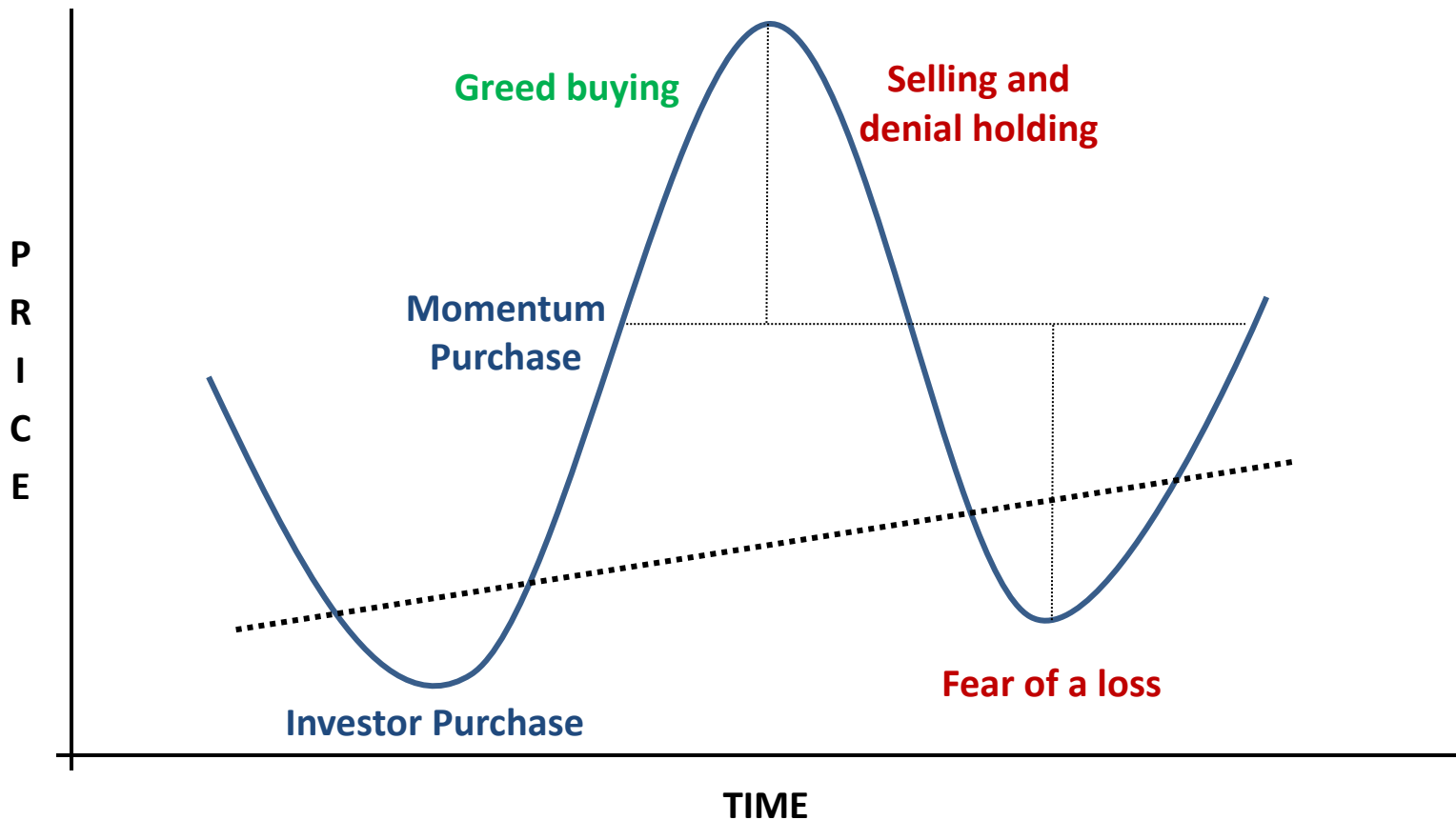
Identify emotional market cycle
